Dear Quaker Pride Readers:

I'm pleased to; once again, serve as President of the Quaker Foundation following my previous one year term in 2009. This year the Board of Directors has elected to change the operating year-end date of the Foundation to June from February. This change coordinates the operating year-end with the fiscal year-end of June 30th. As a result, the Foundation officers and directors will serve from July 1st to June 30th each year.

Awarding scholarships to graduating seniors of New Philadelphia High School is the core focus of the Quaker Foundation. The Quaker Foundation broke all of the previous records this past May at our Awards Banquet when sixty seniors were awarded a total of \$104,500 in scholarships. These results would not and could not be possible without the continuous support of alumni and friends of New Philadelphia City Schools.

Through the efforts of our officers, directors, volunteers and donors, the financial support for the Quaker Foundation continues to grow. I am always amazed at the level of giving and the broad base of donors whom provide support. It is this commitment that has allowed our resources to exceed \$1,000,000 for the first time ever. We have new endowed family scholarship funds that are outlined in this issue of *Quaker Pride*, as well as endowed funds that have been increased and annual scholarship funds that are still growing. In addition, the general giving continues to grow which allows us to maintain the level of scholarships provided despite investment returns being the lowest in our history.

Two other activities important to the Foundation and supported by donors are the Classroom Grants, awarded each year to support special activities developed by teachers, and the Jackson Teacher's Award. The Classroom Grants are designed to encourage teachers to implement programs designed to encourage students to broaden their education experience while the Jackson Teacher's Award is designed to annually recognize an outstanding teacher.

The Foundation made two major event changes this past year. The first change was to hold the Quaker Foundation Alumni Homecoming Event at the new Quaker Dome. This location worked well for the event and we plan to use the Quaker Dome again this fall. The second change involved moving our awards banquet from Union Country Club to the Performing Arts Center on the campus of Kent State Tuscarawas. The awards banquet had outgrown the old location. The Performing Arts Center provided the necessary room for the social part of the event and the theater worked well for the awards presentations.

I want to invite everyone to stop by the Quaker Foundation office on North Broadway to view the large display of Quaker memorabilia. The items on display have come from a variety of sources and cover nearly the entire history of New Philadelphia High School. If you are alumni, I'm sure you will find something relating to your years at New Philadelphia. We are currently working with a muscum professional to upgrade the displays to ensure preservation. We were fortunate to have received a grant from the Stark Community Foundation allowing us to proceed with this small initial step. The preservation process will continue over time as preservation funds allow.

I want to close by again acknowledging the importance of those who support the Quaker Foundation with their time, talents, and finances. We are so grateful and offer our sincere thanks to each of you.

On Saturday, September 29th the annual Quaker Foundation Pancake Breakfast was held at the Tuscora Park Pavilion/Teen Center. Many Alumni took advantage of the tours offered on Saturday at New Philadelphia High School and the Quaker Foundation office located at 124 N. Broadway.

Retired educator **Al Kennedy** was born in Gnadenhutten, Ohio. He is a graduate of Dennison High School, where he was a four year letterman in



varsity basketball. Al attended Wittenberg University, earning a degree in Teaching that included a major in Health and Physical Education and a minor in General Science. His Masters degree in Educational Administration was earned at the University of Dayton.

Al's teaching career began at Dennison High School. He also taught at Conotton Valley and Carrollton before starting at New Philadelphia High School and teaching there for 22 years, retiring in 1992. After two years of retirement, Al returned to teaching at

Conotton Valley High School where he spent 16 years, 14 of those as Principal.

During his time in Education, Al was a Varsity Head Coach in Football,

Boys Basketball, Girls Basketball, Golf, and Track. In 1995, he was named Co-Coach of the year in the State of Ohio in Division VI Football as the Head Coach at Conotton Valley with a 9-1 record. Al was on the Varsity Football staff a New Philadelphia when the 1974 team played in The Ohio State Stadium in the State Semi Finals. In Girls Basketball at New Philadelphia, his record was 160-43 from 1980-89, including eight Sectional Titles, two District Titles, and three District Runner-Up Titles. He was named AAA Coach of the Year for six consecutive years from 1982-87 and Division 1 Coach of the Year in 1989. Al was an Assistant Coach in the 1989 State Girls All Star Game, played at The Ohio State University in St. Johns Arena. For three seasons at Conotton Valley, he was the Varsity Girls Basketball Coach with a 52-16 record and two Sectional Titles. Al was inducted into the District 5 Coaches' Association's Hall of Fame in the Class of 2012.

Al married his late wife, the former Helen Lamonica of Dover, in 1960. They raised one son, Dr. Michael Kennedy, a Professor at Miami University in Ohio. Two grandchildren, Kate, soon to be a Senior at Miami University and William, a Senior in High School, complete the family.

Since his retirement in 2010, Al spends a lot of time on the golf course. He also attends and enjoys watching New Philadelphia football games and boys and girls basketball games.



Cheryl and Bill Graham were the 2012 Spirit Award Honorees. Cheryl Anne Graham is the former director of bands at New Philadelphia and Ridgewood High Schools, from 1969 to 2001. Currently Cheryl teaches K-5 vocal music at Central

and West Elementary where she reintroduced school musicals. With the addition of South Elementary this year she plans to continue community involvement by performing at the Senior Center, Christmas Parade, Community Tree Lighting Service and Christmas in the Park. She is the co-director with her husband, Bill, of the Big, Bad, Bodacious Brass Band, a low brass choir that performs at area churches and community events. She plays French horn in the Kent Stark Band and the Dominic Greco Memorial Band. She adjudicates all areas of marching band as well as large group and solo and ensemble events. Under her direction the Marching Quakers received two Bands of America national titles, numerous BOA regional championships, as well as years of OMEA superior ratings. The Quakers were invited to be featured performers in the parade celebrating the 200th anniversary of the signing of the U.S. constitution in Philadelphia. The concert program under her direction was highlighted by a state OMEA Conference 1998 performance, the Akron Band Director's Conference in December 1998, and a guest concert appearance at Cleveland State University. As continuous participants in all areas of OMEA, Cheryl, with her husband's, help hosted over fifty solo and ensemble contests. She still stays involved with this activity by helping prepare New Philadelphia high school and middle school students for solo and ensemble contests. Cheryl is the general effect caption head for OMEA marching band adjudication as well as concert band and solo and ensemble adjudication. As chairperson of the scholarship committee, Cheryl helps promote First Town Days. She is a graduate of Valley Forge High School, Muskingum College, and The University of Akron. In 2004, she was selected as the outstanding alumnus of the University of Akron's music department

Bill Graham is the Learning Coordinator for the Sandy Valley Local

School District in Stark County and is enjoying his forty-fifth year of teaching. Cheryl and Bill met when she did her student teaching at Riverview High School where Bill was a math teacher for seven years. When the Graham's moved to New Philadelphia, Bill taught both math and science at Joseph Welty Middle School for twenty-eight years. He was the color guard instructor and drill writer for the New Philadelphia Marching Quakers as well as the director of New Philadelphia High School's winter guard, Kaleidoscope. Kaleidoscope, a charter member of the Mid East Performance Association, won many local awards as well as finishing third in Class A at the WGI World Championships during Mr. Graham's last year of leadership. He still teaches trombone lessons as well as writing marching band drills and adjudicating as a timing and penalty judge. Bill was instrumental in organizing the Marching Quaker Alumni Band for the First Town Day's Parades in both 2008 and 2012. Over two hundred alumni have participated in one or both parades. Cheryl and Bill are both members of the First Methodist Church of New Philadelphia where Bill is a member of the hand bell choir. He is also a member of the Outreach Committee and helps serve meals at the Tuesday night soup kitchen. Bill is probably best known for his entertaining children's messages at church and science presentations at the library. He is a graduate of Riverside H.S., Capital University, and Ashland University.

The Graham's are the proud parents of two: the late Chip Graham, and Christina, a graduate of Baldwin-Wallace, who now teaches special education at Cherry Valley Elementary in Newark, Ohio. Christie lives outside of Granville with her husband, Keith, and daughter, Courtney.



Marvin Beans was select to receive the Quaker Foundation Merit Award. Marvin is a lifelong resident of New Philadelphia and a 1945 graduate of NPHS. He served in the Merchant Marines and in the U.S. Army Occupation of Germany in World War II. For 28 years, Marvin worked as a driver and salesman for the Goshen Dairy Company. He originally made his door-to-door deliveries in the company's horse-drawn cart. Marvin later was employed by Jerry Marlowe as a nursing home service and equipment manager

for 21 years.

Marvin has been a Quaker Foundation volunteer since its beginning in 1993, assisting with the mailing of the *Quaker Pride* newsletter each year. Presently, and for the past five years, Marvin volunteers his time in the Quaker Foundation Office, keeping it open when the regular staff is unable to be there. He is a great source of knowledge on much of the history of NPHS and has many great stories to share with those who visit the Quaker Foundation. He has also helped to spread the word of the Mission and Goals of the Quaker Foundation, resulting in educational opportunities for NPHS graduates and promotion of NPHS alumni activities. In addition, Marvin played an instrumental part in having a plaque made, which is on display in the High School Gymnasium, honoring the 1944 "Undefeated and Untied" New Philadelphia Quaker Football Team.

Marvin was married for 44 years to his high school sweetheart, the late Bonnie Lee (Reynolds) Beans. Together they raised three children; the late Tim (Karel) Beans, Diane Beans Murphy, and Ron (Dorraine) Beans. Dr. Kathryn Noonan Balinger, a former scholarship recipient and member of the Class of 2001, wrote to the Quaker Foundation to tell us a little bit about her career path since we last saw her. She agreed to allow us to share her letter. Thank you Dr. Noonan Balinger and congratulations on your successes!

It's hard to believe that it's been more than a decade since I've graduated from NPHS. Thirteen years ago I was stressing about Mrs.

Whitkop's English final and my Calc II grade. My time at New Phila was coming to an end- I was narrowing down options for colleges and applying for various scholarships.

A few weeks leading up to graduation, I attended the Quaker Foundation Scholarship banquet. I remember sitting with family and watching with pride as many of my friends were recipients of several scholarships. I was honored to receive my own generous scholarship and remembered thinking what a great graduating class we had that year. So much potential, so much drive, and so ready for the next chapter to come.

Life after NPHS took me to Ohio Wesleyan and my time there flew by. I would like to write that I studied every waking moment, got the highest grades in every class, and devoted my life to the pursuit of academic fulfillment. This was not the case. My parents actually had to drive down to OWU (bringing my precious grandma along) and sat me down for a career intervention in order to convince me that I shouldn't pursue my new dreams of becoming a rock star or at least the next Alicia Keyes. I managed to get back on track and did well enough academically, but had a pretty good life outside of the classroom as well. I made mistakes, I stumbled, I found out that I was fallible and human- that in itself humbled me a great deal.

Long story short, I put my dreams of being a piano playing rock star on hold and pursued a career in medicine. Life next took me to Eastern Virginia Medical School in Norfolk, VA, where I finished a masters in biomedical science. I met my husband, Chris, there and we both started medical school there the following year. Chris and I went to Orlando after graduation and completed a preliminary surgery internship there. We then couples matched to the same general surgery program at St. Luke's University Hospital in Bethlehem, Pa, where we are now halfway done with our residency training. Chris is planning on doing a plastic surgery fellowship after residency and I am thinking about doing a trauma surgery fellowship when we're done here.

I don't get the chance to come back home to New Phila much these days. But when I do, I get genuinely excited- not just about seeing family and seeing friends. It's about being in the place where I played on the awesome jungle gym at South Elementary, the place where I had so many awkward middle school memories and the place where I came into my own at NPHS. I have so much pride when it comes to the community I grew up in and look forward to someday showing my future children the place I will always call home.

Now that we are entering the 20th year since being established in 1993, we are really able to see and take pride in the many fantastic accomplishments of those who have been awarded Quaker Foundation Scholarships. The new award, presented for the first time in 2013, recognizes previous scholarship recipients for outstanding achievement in their career choice. Our Board Members have been busy trying to keep in contact with past recipients and are very interested in their accomplishments. The very first recipient of the Alumnus of the Year-Previous Scholarship Recipient Award was Andy Francis (NPHS '97). We would like to share the speech Andy gave after being presented with the award at the Quaker Foundation Recognition Banquet.

Hello everyone, good evening, very nice to see you all. It's been nice to be back to New Phila. I haven't been here in a while and it was very good to see the area and meet with some people I haven't seen in some time. First of all, thank you very much to the Quaker Foundation for inviting me and my fellow honorees this evening and for all the good work they do here in New Philadelphia. I'd really also like to congratulate all of the award and scholarship recipients here tonight, for all they've done and all they will do in the future.

As Mr Nemitz said, the Quaker Foundation has been kind enough to give me their inaugural Scholarship Alumni Award, which is something that I was really surprised by and appreciative of. An award for...them having giving me an award. I feel very fortunate to be the first, and, as Mr. Stratton is fond of reminding me, 100 years from now I'll still be the first.

Of course, 100 years from now, who knows what the Quaker Foundation will be up to – if the years since I graduated are any indication, it's going to be great things. I did a little research on the Quaker Foundation's scholarship program and found some very interesting and exciting things.

When I graduated, in 1997, the Quaker Foundation awarded five scholarships worth a total of \$8 000. Thanks to their hard work and philanthropic spirit, and the generosity of the community, in 2012 they awarded 54 scholarships totaling nearly one hundred thousand dollars. That kind of growth and dedication is really remarkable.

As you might know, I am a scientist - a materials scientist, to be exact. Inevitably when I tell people that, I get the same question: what is that? Well, my girlfriend has this notion that I sit in my lab in a white coat, presumably with those big dorky rubber high school science class goggles, and that I clink together colored test tubes, which of course are giving off fumes, and I occasionally sit like this [twiddles fingers diabolically] and think. That's not exactly true, but one of the things I do as a scientist is use data to build models. So, given the Foundation's impressive growth over the years and Mr. Stratton's comment about 100 years from now, I felt like I should extrapolate that data a little bit and develop a predictive model or two for what the 2113 Quaker Foundation

awards banquet might look like. I started with a simple linear model (I had to make a few tiny assumptions), a hundred years from now, Quaker Foundation annual banquet attendees will witness three hundred twenty-nine scholarships worth nearly \$700 thousand! How about that? I hope they keep the speeches short. If I use a more aggressive geometrical model instead, we'll expect them to award four thousand, three hundred scholarships, worth a total \$400 billion. Yikes. Now, it's entirely possible that I haven't constructed this model with a whole lot of precision, but don't let that take away from the tremendous work the Quaker Foundation has done for the students of this community.

In the sixteen years since I was last here, I've come to be very appreciative of the education I got from New Philadelphia City Schools, as well as, of course, the generosity of the Quaker Foundation. I believe very strongly in public education, and I think that can be traced back to my own experiences as a kid. At NPHS I really learned all the academic tools I needed to succeed in college - even today, even in situations where I'm not talking at a banquet in New Phila, I tell people very sincerely about how well-prepared I was for Carnegie Mellon. Everything from Mr Wherley's four-box unit analysis technique to Mrs. Wittkop's essay-writing strategies to Mrs. Beitzel's careful approach to mathematical development - it all put me in a really good position to get the most out of higher ed. Thanks to the generosity of the Quaker Foundation, my family and I were able to put those academic tools to good use, at university and still today. Thank you.

The New Philadelphia City Schools

The Quaker Foundation's annual awards banquet was held May 3, 2013 at the Kent State University Performing Arts Center. The alumni honored were: John Hoopingarner, John R. (Bob) Meese, and Andy Francis. Also honored was New Philadelphia High School Teacher, Jeffrey A. Furbay.

Alumnus of the Year for Special Achievement Award



John Hoopingarner is a 1972 graduate of New Philadelphia High School and a 1976 cum laude graduate of Muskingum College (now Muskingum University) with a bachelor's degree in history. In 1979, he received a law degree from Claude W. Pettit School of Law at Ohio Northern University. John worked eight summers at Tuscora Park during his high school and college years.

He returned to New Philadelphia after law school to join the law firm of Hanhart, Miller & Kyler, becoming a partner in 1985 and serving as legal counsel to the Muskingum Watershed Conservancy District (MWCD) for ten years. He also was an instructor of real estate law at Kent State University Tuscarawas. He was elected a Director of The Citizens Bank in 1991 and of The United Bancorp, Inc. (NASDAQ:UBCP) in 1996. In 1989, John became the third person to lead the MWCD, following Bryce C. Browning and Raymond E. Eichel. He is currently in his 24th year as Executive Director/Secretary of the MWCD. The MWCD is dedicated to providing the benefits of flood reduction, conservation and recreation in the Muskingum River Watershed. It employs nearly 400 persons with an annual budget of approximately \$22 million. The MWCD system of dams and reservoirs has prevented more than \$10 billion in property damage and is host to more than 5 million recreation visitors each year.

John has served on numerous boards of both non-profit and government related organizations, including the Tuscarawas County YMCA, Tuscarawas County Board of Developmental Disabilities, Ohio Association of County Boards of Developmental Disabilities, The Foundation for Appalachian Ohio, Dover Public Library, Water Management Association of Ohio, and the Ohio Water Advisory Council. John's connection with water dates to his early childhood. He has been a competitive swimmer most of his life, setting numerous records in YMCA and collegiate swimming. He was inducted into the Muskingum University Athletic Hall of Fame in 2001, achieved All-America recognition, and continues to swim as a masters swimmer today, ranking in the top 10 nationally in his age group in distance freestyle events. John and his family have enjoyed sailing on Atwood Lake and in a variety of destinations in the Caribbean Sea, and the Atlantic and Pacific Oceans. He and his wife, Susan, have two adult children, Scott (Abby) Hoopingarner, and Katie (Kyle) Mears, and one grandchild, Dylan Hoopingarner.

Alumnus of the Year for Distinguished Service Award



John R. (Bob) Meese's academic achievement as a 1950 graduate of New Philadelphia High School earned him a full tuition scholarship to Case Institute of Technology in Cleveland, Ohio. For over two years he studied to pursue a chemical engineering degree but in 1953 he decided to enlist in the U.S. Army. Bob's basic and advanced training took place at Fort Leonard Wood, Missouri.

He was selected for Officer Candidate Training at Fort Benning, Georgia. He completed the six month intensive academic and physical training at the top of his class and was selected as a distinguished graduate and appointed as a 2nd Lieutenant. Over the next more than 30 years of service, Bob progressed through the officer ranks, serving in command and staff positions in Infantry, Airborne, and Special Forces, operating units specializing in intelligence and operations. Bob served multiple tours of combat duty in Vietnam with the 173rd Airborne Brigade and the 7th Special Forces Group. As a counterinsurgency specialist, he also performed advisory duties with the Venezuelan Armed Forces and Province Advisor for Chuong Thien Province in Vietnam. As Bob moved from the company grade into field grade ranks, he served as the Deputy Chief of Staff for Operations and Training, 6th U.S. Army Headquarters at the Presidio of San Francisco and Deputy Chief of Staff-Intelligence of U.S. Army Western Command at Fort Shafter, Hawaii. His final assignment was the U.S. Army's representative for the source selection of the next Air Force Cargo Aircraft—the C-X. His assignment and instructions came from the Chief of Staff of the Army and directed exactly what capabilities the aircraft must incorporate to provide an air vehicle capable of lifting Army units and equipment to respond to national requirements. Bob retired in October of 1983 as a Colonel, USA, Infantry. A partial list of awards and decorations recognizing Bob's exemplary service includes; Legion of Merit (3 OLC), Bronze Star Medal, Air Medal (1 VDEV/5 awards), Army Commendation Medal (2 OLC), Purple Heart, National Defense Service Medal, Republic of Vietnam Campaign Medal W 60 Device, Overseas Service Bars (5), Combat Infantryman Badge, Master Parachutist Badge, Ranger Tab, and Venezuelan Parachutist Badge.

Following his retirement, Bob accepted employment with the Boeing Company's Military Division in Wichita, Kansas. At Boeing, Bob worked in the Research and Development of small, long range aircraft that were required to deploy and recover Army Special Forces and U.S. Navy Seal units in response to worldwide requirements. After more than seven years, he moved on to a consultant's position within Boeing which he held for five more years. In 2003, Bob returned to his New Philadelphia roots for permanent retirement. He currently enjoys being back "home" and supports the Quaker Foundation as the point of contact for his 1950 NPHS Class.



Classroom Grants Awarded to Teachers





Each year, since 1993, the Quaker Foundation awards Classroom Grants to benefit students and staff of New Philadelphia City Schools. Since that first year, when six grants were awarded totaling \$1,575, the Classroom Grant Program has grown to fund 30 grants this past school year at a total dollar amount of \$14,256.

Among those receiving Quaker Foundation Grants in 2012/2013 were high school librarian, Ashley Claxon, and Welty Middle School teacher, Jessica Felton.

With her grant, Ashley Claxon was able to fund a project called "Translate to Relate". Teachers and students were able to use Spanish Language/English Language paired book kits for independent reading. The materials selected presented high interest topics in lower reading level formats which were manageable reads for new English learners as well as special education students.

Mrs. Felton used her grant to fund a project titled "Kindles in the Classroom". Students used Kindles as a resource to choose from over 1,500 digital books to read. Magazine articles and endless possibilities for non-fiction literature were also made available to students with the Kindles purchased with this Quaker Foundation Grant.
